AN ORDINANCE ESTABLISHING RESPONSIBILITY FOR
PERFORMANCE OF CITY ENGINEER FUNCTIONS IN THE
CITY OF SAN DIEGO.

WHEREAS, various sections of the San Diego Municipal Code require enforcement, supervision, certification and other functional activities by the City Engineer; and

WHEREAS, the Subdivision Map Act of the State of California (Business and Professions Code, Section 11500 et seq.) requires certification of maps by the City Engineer; and

WHEREAS, the position of City Engineer no longer exists within the organizational structure of The City of San Diego; and

WHEREAS, Section 22.1003 of the San Diego Municipal Code provides that whenever functions are required of an officer designated by a title which no longer exists, authority or duty for such function shall be designated by ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to the San Diego Municipal Code, Section 22.1003, the Assistant City Manager of The City of San Diego be designated as City Engineer and he is hereby fully authorized and empowered to perform all duties and responsibilities imposed upon and required of the City Engineer by the laws of the State of California and ordinances of The City of San Diego.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

WHEREAS the position of City Engineer exists within the organizational structure of The City of San Diego and

WHEREAS Section 221003 of the San Diego Municipal Code provides that various functions are required to be performed by a title and the authority of such position shall be designated by ordinance NOW, THEREFORE

IT IS ORDAINED by the Council of the City of San Diego as follows:

Section 221003 of the San Diego Municipal Code, Section 221003, shall be amended to read as follows: "The City Manager of The City of San Diego be designated as engineer and he is hereby fully authorized and empowered to perform the duties and responsibilities imposed and required by the City Engineer of the laws of the State of California and ordinances of The City of San Diego."

This ordinance shall take effect and be in force on the thirtieth day and after its passage, which date is July 25, 1972, and adopted by the Council of the City of San Diego on August 17, 1972.
