
AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1

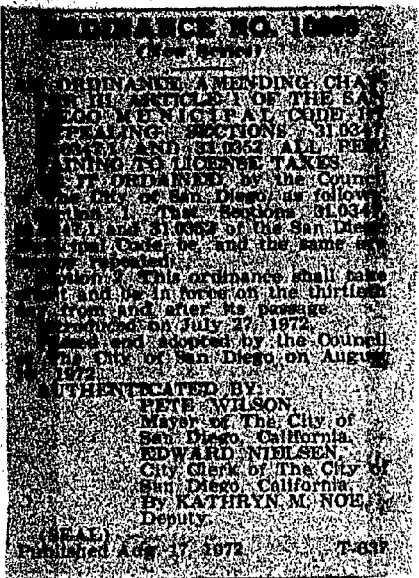
