AN ORDINANCE INCORPORATING THAT CANYON AREA LYING WESTERLY OF CATALINA BOULEVARD AND EASTERLY OF THE PACIFIC OCEAN, BETWEEN THE UNITED STATES MILITARY RESERVATION ON THE SOUTH AND HILL STREET ON THE NORTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That canyon area lying westerly of Catalina Boulevard and easterly of the Pacific Ocean, between the United States Military Reservation on the south and Hill Street on the north, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing Nos. C-373.1 and C-373.2, filed in the office of the City Clerk as Document No. 740633 be, and it is hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
