AN ORDINANCE INCORPORATING CERTAIN PROPERTY IN THE COWLES MOUNTAIN, LAKE MURRAY, AND NAVAJO AREAS, LOCATED BETWEEN MISSION GORGE ROAD AND THE SAN DIEGO CITY LIMITS AND INTERSTATE 8, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 AND R-1-20 ZONES, AS DEFINED BY SECTIONS 101.0404 AND 101.0407, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 148 (NEW SERIES), ADOPTED FEBRUARY 6, 1933, ORDINANCE NO. 8664 (NEW SERIES), ADOPTED JUNE 21, 1962, AND ORDINANCE NO. 13457, APPROVED FEBRUARY 15, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That certain property in the Cowles Mountain, Lake Murray, and Navajo areas, located between Mission Gorge Road and the San Diego City Limits and Interstate 8, in the City of San Diego, California, within the boundaries of the districts designated "A-1-10" and "R-1-20" on Zone Map Drawing No. C-369.1, filed in the office of the City Clerk under Document No. 740286 be, and it is hereby incorporated into A-1-10 and R-1-20 Zones, as described and defined by Sections 101.0404 and 101.0407, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 148 (New Series), adopted February 6, 1933, Ordinance No. 8664 (New Series), adopted June 21, 1962 and Ordinance No. 13457, approved February 15, 1932 be, and the same are hereby repealed insofar as they conflict herewith.
