AN ORDINANCE INCORPORATING THOSE CANYON AREAS LYING WESTERLY OF INTERSTATE HIGHWAY 5 AND EASTERLY OF THE CITY OF DEL MAR AND THE ATCHISON, TOPEKA AND SANTA FE RAILROAD, BETWEEN DEL MAR HEIGHTS ROAD ON THE NORTH AND CARMEL VALLEY ROAD ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those canyon areas lying westerly of Interstate Highway 5 and easterly of the City of Del Mar and the Atchison, Topeka and Santa Fe Railroad, between Del Mar Heights Road on the north and Carmel Valley Road on the south, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-374.1, filed in the office of the City Clerk as Document No. 740604 be, and they are hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
