AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 31.0302, 31.0373 AND 31.0375, RELATING TO LICENSES AND LICENSE TAX.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 31.0302 of the San Diego Municipal Code, be, and the same is hereby amended to read as follows:

SEC. 31.0302 LICENSES -- TWO OR MORE BUSINESSES AT SAME LOCATION

Whenever any person is engaged in two or more retail businesses at the same location, in a retail and wholesale business at the same location, or has two or more wholesale businesses at the same location, such person shall not be required to obtain licenses for the conducting of each of such businesses, but shall be issued a joint license, and the average number of employees of all of such businesses so conducted shall be used as a basis for computing the amount of license fee to be paid for the conduct of all such businesses.

Section 2. That Section 31.0373 of the San Diego Municipal Code, be, and the same is hereby amended to read as follows:

SEC. 31.0373 LICENSE TAX -- SELLING GOODS, WARES OR MERCHANDISE AT WHOLESALE

Every person selling goods, wares or merchandise at wholesale shall pay annually a license tax of Twenty-five Dollars (\$25.00), plus a sum of money equal to Two Dollars (\$2.00) per year per employee for the average number of employees employed during the preceding six (6) months. In determining the average number of employees employed during the preceding six (6) months, the number of employees at the beginning of such period shall be added to the number of employees at the end of such period and the sum thereof divided by two.

Section 3. That Section 31.0375 of the San Diego Municipal Code, be, and the same is hereby amended to read as follows:

SEC. 31.0375 MANUFACTURING, PROCESSING, FABRICATING INCIDENTAL TO WHOLESALE OR RETAIL SELLING -- LICENSING REQUIREMENTS

When manufacturing, processing or fabricating is done in connection with the business of selling at wholesale or at retail or both, and is done incidental thereto, such business shall be licensed under Section 31.0373 or Section 31.0374, whichever the case may be.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
