AN ORDINANCE REPEALING ORDINANCE NO. 10679 (NEW SERIES), ADOPTED SEPTEMBER 9, 1971, INCORPORATING CERTAIN PROPERTY IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 10679 (New Series), adopted September 9, 1971, and entitled, "AN ORDINANCE INCORPORATING A PORTION OF THE SOUTHEAST 1/4 OF SECTION 13, AND A PORTION OF THE NORTHEAST 1/4 OF SECTION 24, TOWNSHIP 14 SOUTH, RANGE 4 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8018 (NEW SERIES), ADOPTED DECEMBER 9, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.", be and it is hereby repealed in its entirety.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
