ORDINANCE NO. (New Series)

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.0101.54 RELATING TO DEFINITIONS AND INTERPRETATIONS - HISTORICAL SITE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1 of the San Diego Municipal Code be amended by adding Section 101.0101.54 to read as follows:

101.0101.54 HISTORICAL SITE SEC.

Any site (including significant trees or other plant life located thereon), building, structure, or mark of historical significance due to its association with such things as noted in past events, historical persons, or distinguishing architectural characteristics. Such site shall be so designated by the Historical Site Board in accordance with the procedures set forth in the Municipal Code, as well as any other sites so designated by other governmental agencies.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
