ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING LOTS 29 AND 30, GRANADA TRACT, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12989, APPROVED OCTOBER 20, 1930 AND ORDINANCE NO. 184 (NEW SERIES), ADOPTED MARCH 20, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 29 and 30, Granada Tract, in The City of San Diego, California, within the boundary of the district designated "C-1" on Zone Map Drawing No. B-2634.1, filed in the office of the City Clerk under Document No. 740710 be, and they are hereby incorporated into C-1 Zone, as such zone is described and defined by Section 101.0430.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12989, approved October 20, 1930 and Ordinance No. 184 (New Series), adopted March 20, 1933 of the Ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
