## ordinance no. 1091

(New Series)

AN ORDINANCE INCORPORATING BLOCKS 14 THROUGH 19; LOTS 25 THROUGH 48, BLOCK 13; AND LOTS 25 THROUGH 48, BLOCK 20; SWAN'S ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0407 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057, APPROVED DECEMBER 22, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Blocks 14 through 19; Lots 25 through 48, Block 13; and Lots 25 through 48, Block 20; Swan's Addition, in the City of San Diego, California, within the boundaries of the districts designated "R-1-5" and "R-2" on Zone Map Drawing No. B-2642.2, filed in the office of the City Clerk under Document No. 741143 be, and they are hereby incorporated into R-1-5 and R-2 Zones, as described and defined by Sections 101.0407 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 13057, approved December 22, 1930, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
