AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 10302 (NEW SERIES), ADOPTED MAY 28, 1970, INCORPORATING LOT G AND A PORTION OF LOT H, BLOCK 383, HORTON'S ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO RP ZONE, AS DEFINED BY SECTION 101.0419 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 10302 (New Series), adopted May 28, 1970; and

WHEREAS, Section 1 of Ordinance No. 10302 (New Series), provided that the RP Zone would attach if a final parcel map were recorded on or before June 27, 1972; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 10302 (New Series), adopted May 28, 1970, be, and it is hereby amended to read as follows:

Section 1. That in the event that a final parcel map is recorded on or before December 27, 1972, on Lot G and a portion of Lot H, Block 383, Horton's Addition, in the City of San Diego, California, within the boundary of the district designated RP on Zone Map Drawing No. B-2292, and provided the conditions as required by the City Engineer in Document No. 731606 are met, the provisions of Section 101.0419 of

the San Diego Municipal Code shall attach and become applicable to the said land and the said land shall be incorporated into RP Zone, as described by Section 101.0419, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2292, filed in the office of the City Clerk as Document No. 731605.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
