AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING DIVISION 21, SECTIONS 22.2101 AND 22.2102 RELATING TO THE DEPARTMENT OF COUNCILMANIC ADMINISTRATION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, of the San Diego Municipal Code be and the same is hereby amended by adding Division 21, Sections 22.2101 and 22.2102 to read as follows:

## Division 21

Department of Councilmanic Administration
SEC. 22.2101 DEPARTMENT OF COUNCILMANIC ADMINISTRATION

The Department of Councilmanic Administration is a City Department. The Principal Assistant to the City Council is the Director and the administrative head of the department. He is appointed by and may be removed by a majority of the Council.

SEC. 22.2102 POWERS AND DUTIES OF THE DIRECTOR OF COUNCILMANIC ADMINISTRATION

The Director of Councilmanic Administration shall, under the administrative and policy direction of the Deputy Mayor, be responsible for coordinating all the intra and intergovernmental administrative functions of the City Council, and the several departments thereof. The department shall provide administrative services for all Council departments. The department shall further provide coordination and liaison as directed by the Council.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
