AN ORDINANCE AMENDING ORDINANCE NO. 10845 (NEW SERIES), AS AMENDED, TO CREATE THE UNCLASSIFIED POSITION OF COUNCIL ASSISTANT AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.
