AN ORDINANCE INCORPORATING THAT CERTAIN PROPERTY BOUNDED BY INTERSTATE HIGHWAY 805, INTERSTATE HIGHWAY 5, INTERSTATE HIGHWAY 15, AND STATE HIGHWAY 163, KNOWN AS THE DEL MAR TERRACE-MIRAMAR TRACT ANNEXATION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10, A-1-5, A-1-1, R-1-20, R-1-5, AND CA ZONES, AS DEFINED BY SECTIONS 101.0404, 101.0407, AND 101.0428.1, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8018 (NEW SERIES), ADOPTED DECEMBER 9, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That certain property bounded by Interstate
Highway 805, Interstate Highway 5, Interstate Highway 15, and
State Highway 163, known as the Del Mar Terrace-Miramar Tract
Annexation, in the City of San Diego, California, within the
boundaries of the districts designated "A-1-10," "A-1-5," "A-1-1,"
"R-1-20," "R-1-5," and "CA" on Zone Map Drawing No. C-375, filed
in the office of the City Clerk under Document No. 741103 be,
and they are hereby incorporated into A-1-10, A-1-5, A-1-1, R-1-20,
R-1-5, and CA Zones, as described and defined by Sections 101.0404,
101.0407, and 101.0428.1, respectively, of the San Diego Municipal
Code.

Section 2. That Ordinance No. 8018 (New Series), adopted December 9, 1958, of the Ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.
