ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING LOTS 1 THROUGH 4, BLOCK 52, OCEAN BEACH AND A PORTION OF NIAGARA AVENUE CLOSED, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S ZONE, AS DEFINED BY SECTION 101.0430 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12793, APPROVED APRIL 14, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map or maps, is recorded on Lots 1 through 4, Block 52, Ocean Beach and a portion of Niagara Avenue closed, in the City of San Diego, California, designated "C-1S" on Zone Map Drawing No. B-2648.1, the provisions of Section 101.0430 of the San Diego Municipal Code shall attach and become applicable to the said land and the said land shall be incorporated into C-1S Zone, as described by Section 101.0430, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2648.1, filed in the office of the City Clerk as Document No. 741081. Said zoning shall attach only to those areas included in the parcel map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 12793, approved April 14, 1930, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
