ORDINANCE NO. 10951 NOV 91972

AN ORDINANCE INCORPORATING THOSE CANYON AREAS LYING NORTHERLY OF CARMEL VALLEY ROAD, BETWEEN INTERSTATE HIGHWAY 5 ON THE EAST AND THE ATCHISON, TOPEKA AND SANTA FE RAILROAD ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those canyon areas lying northerly of Carmel Valley Road, between Interstate Highway 5 on the east and the Atchison, Topeka and Santa Fe Railroad on the west, in the City of San Diego, California, within the boundaries of the districts designated "LC" on Zone Map Drawing No. C-376.1, filed in the office of the City Clerk as Document No. 741459 be, and they are hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
