ORDINANCE NO. 10958 DEC 5 1972

AN ORDINANCE INCORPORATING ALL THAT C ZONED PROPERTY, BOUNDED BY PACIFIC BEACH DRIVE ON THE NORTH, THE PACIFIC OCEAN ON THE WEST, MISSION BAY CHANNEL ON THE SOUTH, AND MISSION BAY PARK ON THE EAST, MISSION BEACH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CS ZONE, AS DEFINED BY SECTION 101.0432 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 119 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that C zoned property, bounded by Pacific Beach Drive on the North, the Pacific Ocean on the West, Mission Bay Channel on the South, and Mission Bay Park on the East, Mission Beach, in the City of San Diego, California, within the boundary of the district designated "CS" on Zone Map Drawing No. C-378, filed in the office of the City Clerk under Document No. 741672 be, and it is hereby incorporated into CS Zone, as such zone is described and defined by Section 101.0432 of the San Diego Municipal Code.

Section 2. That Ordinance No. 119 (New Series), adopted January 3, 1933, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
