

ORDINANCE NO. 10962 DEC 21 1977
(New Series)

AN ORDINANCE INCORPORATING LOTS J, K, AND L, BLOCK 355, HORTON'S ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-4C ZONE, AS DEFINED BY SECTION 101.0415 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12987, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded on Lots J, K, and L, Block 355, Horton's Addition, in the City of San Diego, California, designated "R-4C" on Zone Map Drawing No. B-2679, the provisions of Section 101.0415 of the San Diego Municipal Code shall attach and become applicable to the said land and the said land shall be incorporated into R-4C Zone, as described by Section 101.0415, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2679, filed in the office of the City Clerk as Document No. 741797.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 12987, approved October 20, 1930, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.
