All being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portion of a public street, to wit: a portion of 54th Street for public purposes and said portion of a street is hereby declared to be portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in the certificate signed by the Owners subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and those certain easements listed in the certificate signed by the Owners subject to the conditions expressed therein, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
