RESOLUTION NO. 204581

APPROVING MAP OF MIRA MESA VERDE UNIT NO. 19 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, Licensed Land Surveyor, and entitled, "MIRA MESA VERDE UNIT NO. 19 Being a subdivision of a portion of the Southwest Quarter of Section 36, Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets and portions of public streets, to wit: Flanders Drive, Calico Street, Calico Circle, Manila Avenue, Manila Circle, Lakeport Road, Amantha Avenue, Kenova Street, Columbus Street, Casa Blanca Place, a portion of Camino Ruiz and a portion of Reagan Road for public purposes, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all vehicular access rights in and to Reagan Road, adjacent and

contiguous to Lots 3754, 3755 and 3761, and any and all vehicular access rights in and to Camino Ruiz, adjacent and contiguous to Lots 3751, 3752, 3753, and 3762, as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain vehicular access rights and the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
