BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, covering participation by the State and the City in the construction of traffic signals and safety lighting at the intersection of Alvarado Canyon Road and the westbound off-ramp from Route 8 with Fairmount Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 738560.

BE IT FURTHER RESOLVED, that the expenditure of \$25,000 is hereby authorized from Gas Tax Fund 220 solely and exclusively for the purpose of providing funds for City's share in the construction cost of the traffic signals and safety lighting described above.
