WHEREAS, application for transfer of 14 Certificates of Public Convenience and Necessity to Pleasureline Products, Inc., dba ABC Cab Company, has been received from Brokers Mortgage Company, dba San Diego Cab Company; and

WHEREAS, the City Manager has made his recommendation pursuant to San Diego Municipal Code, Section 72.01; and

WHEREAS, these same 14 Certificates of Public Convenience and Necessity were originally transferred to San Diego Cab Company in order that minority business opportunity and employment for individuals within the Southeast San Diego area may be created and increased taxi service within the Southeast San Diego area could be accomplished; and

WHEREAS, these same 14 Certificates of Public Convenience and Necessity were transferred, by approval of this City Council, from San Diego Cab Company to Brokers Mortgage Company, a corporation, predominantly owned by residents of Southeast San Diego, in order that the same extended service to Southeast San Diego would be continued; and

WHEREAS, Pleasureline Products, Inc. is a firm based outside of Southeast San Diego, supplying little, if any, minority business opportunity and employment to the Southeast San Diego area; and

WHEREAS, there has been no indication that Pleasureline Products, Inc. will continue the extended service to

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, Licensed Land Surveyor, and entitled, "LA JOLLA ALTA UNIT NO. 4 Being a subdivision of a portion of Pueblo Lot 1780 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of said map was filed in the office of the County Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Calle Miramar, Calle de Cinco, Calle Leticia, Calle Delicada and Calle Candela, for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

The said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Calle Leticia, adjacent and contiguous to Lots 198 through 211; in and to Calle Delicada, adjacent and contiguous to Lots 186 through 197; in and to Calle Candela, adjacent and contiguous to Lots 168 through 178; in and to Calle Camile, adjacent
