WHEREAS, Brokers Mortgage Co. is presently endeavoring to sell its taxicab business; and

WHEREAS, this Council wishes to give Brokers Mortgage Co. every opportunity to locate a buyer who will continue to provide taxicab service within Southwest San Diego, as the public convenience and necessity requires; and

WHEREAS, discontinuance of operation by Brokers Mortgage Co. of San Diego Cab Co. for a period of not more than 30 days will allow Brokers Mortgage Co. to more adequately seek buyers for San Diego Cab Co. without a serious and permanent detriment to the public convenience and necessity; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to subparagraph K(3) of Section 72.01 of the San Diego Municipal Code, the Council hereby grants its permission for Brokers Mortgage Co. to discontinue the operation of San Diego Cab Co. for a period of 30 consecutive days to begin from January 6, 1972.
