APPROVING MAP OF CALGROVE INDUSTRIAL PARK SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "CALGROVE INDUSTRIAL PARK Being a subdivision of portions of Lots 38 and 43 of the Highlands, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 284, filed in the office of the County Recorder of said County, together with portions of Convoy Street, Vickers Street and Mercury Street as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the portions of public streets, to wit: a portion of Vickers Street, a portion of Ronson Road and a portion of Mercury Street for public purposes, and said portions of public streets are hereby declared to be portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map
to the Clerk of the Board of Supervisors of the County of
San Diego, California.
