


RESOLUTION No. 204612

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$36,994.00 by R. E. Hazard Contracting Company, a corporation, for the IMPROVEMENT OF MIRA MESA BOULEVARD, EASTERLY OF REAGAN ROAD TO I-15 (HWY 395) Schedule II in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738187.
2. That the expenditure of \$46,000.00 is hereby authorized out of the Gas Tax Fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF MIRA MESA BOULEVARD, EASTERLY OF REAGAN ROAD TO I-15 (HWY 395) Schedule II in the City of San Diego, and related costs.
