

RESOLUTION NO. 204622 JAN 11 1972

APPROVING MAP OF LA JOLLA VILLAGE APARTMENTS UNIT NO. 1 SUBDIVISION.


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by G. WILLIAM ROSE, Licensed Land Surveyor, and entitled, "LA JOLLA VILLAGE APARTMENTS UNIT NO. 1 Being a subdivision of a portion of Pueblo Lot 1295 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which was filed in the office of County Recorder of San Diego County, and is known as Miscellaneous Map No. 36 and a portion of Cameron Street as closed to public use and a portion of Block 9 of Leavitts Addition according to Map thereof No. 117 filed in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public street, to wit: Via Mallorca for public purposes, and said street is hereby declared to be public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
