

RESOLUTION NO. 204625

APPROVING MAP OF LA JOLLA VILLAGE
APARTMENTS UNIT NO. 2 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by G. WILLIAM ROSE, Licensed Land Surveyor, and entitled, "LA JOLLA VILLAGE APARTMENTS UNIT NO. 2 Being a subdivision of portions of Pueblo Lots 1279, 1291, 1295, and 1296, (said portion of Pueblo Lot 1296 having been vacated and excluded from the Map of Leavitts Addition, Map No. 117, by S.C.C. 53819.), of the Pueblo Lands of San Diego, City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which was filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36 and portions of Blocks 8, 9, 10, 15, and 16 and of streets and alleys now vacated and closed to public use, adjoining said Blocks in Leavitts Addition, in said City, according to Map thereof No. 117, filed in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets, to wit: Via Mallorca, Via Alicante, Via Sonoma and Via Marin for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, the City of San Diego, a municipal corporation, hereby accepts the open space easement granted on this map, subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Gilman Drive adjacent and contiguous to Lot 2, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are hereby accepted on behalf of the public as heretofore stated; and those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the open space easement, together with those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
