

RESOLUTION NO. 204613 JAN 13 1972

APPROVING MAP OF GENESEE HIGHLANDS  
UNIT NO. 4 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by RICHARD T. STANDISH, Registered Civil Engineer, and entitled, "GENESEE HIGHLANDS UNIT NO. 4 Being a subdivision of portions of Pueblo Lots 1292, 1293 and 1294 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the office of County Recorder of San Diego County, and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street and portion of public street, to wit: Arriba Street and a portion of Regents Road for public purposes, and said street and portion of street are hereby declared to be public street and portion of public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those certain easements listed in the certificate signed by the Owners shown on Sheets 1 and 2 of this map, subject to the conditions expressed therein.

BE IT FURTHER RESOLVED, that the said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Regents Road adjacent and contiguous to Lots 9 and 10, together with the 15.00 foot pedestrian and non-motor vehicular easement, all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public street and portion of public street is accepted on behalf of the public as heretofore stated; and those certain easements listed in the certificate signed by the Owners subject to the conditions expressed therein, together with those certain abutters' rights of access, together with the non-motor vehicular easement as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
