APPROVING MAP OF MESA VILLAGE UNIT NO. 1 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by W.R. NOTHOMB, Licensed Land Surveyor, and entitled, "MESA VILLAGE UNIT NO. 1 Being a subdivision of a portion of Lot 3, Section 31, Township 14 South, Range 2 West, San Bernardino Meridian according to Official Plat thereof; Lots 106 to 112 inclusive, a portion of Lot 105, a portion of Hillery Drive and a portion of Westonhill Drive, all of Mira Mesa Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map 5326 filed in the office of the County Recorder of San Diego County January 14, 1964 and a portion of Westonhill Drive as dedicated on the map of Mira Mesa Verde Unit No. 3, Map No. 6466 filed in the office of the County Recorder of San Diego County on August 29, 1969 and a portion of Westonhill Drive as dedicated on the Map of Mira Mesa Verde Unit No. 9, Map No. 6517, filed in the office of the County Recorder of San Diego County on October 21, 1969, together with Hedgley Avenue and Isleworth Avenue as vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in the Owner's certificate, for general utility and access purposes; and open space, under the conditions expressed therein, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and those certain easements listed in the certificate signed by the Owners subject to the conditions expressed therein, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
