WHEREAS, The City of San Diego is the owner of a certain easement for water purposes affecting a portion of Lot 1 of Friar Gardens, according to Map thereof No. 6576, filed January 22, 1970, in the office of the San Diego County Recorder; and

WHEREAS, the owners of said Lot 1 have requested an exchange of easements to allow better utilization and development of the property; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; and

WHEREAS, the value of the property rights to be exchanged are equal, as determined by the Property Department staff of said City, being the sum of \$50.00 each; and

quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD of Lot 1
of Friar Gardens, an existing easement for water purposes
affecting a portion of Lot 1 of Friar Gardens, as more
particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Mayor of said City for execution and transmittal to the Property Director of said City for recordation.
