BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Lease Agreement with BROWNING MANUFACTURING COMPANY, as lessee, leasing portions of Buildings 13, 50, 70, 82, 131, 133 and 138, and 19,000 square feet of vacant land area lying northerly of Building 13, at Brown Field, for a term of one (1) year ending November 30, 1972, at a rental of \$1,345.00 per month, for the purpose of manufacturing of bows and arrows, flat fiberglass sheet for bow backing, finishing rod handles and wrapping line guides for fishing rods, under the terms and conditions set forth in the form of Lease Agreement, on file in the office of the City Clerk as Document No. 738714.
