BE IT FURTHER RESOLVED, that the expenditure of \$53,000 is hereby authorized from Park and Recreation Bond Fund 725 solely and exclusively for the purpose of providing funds for the professional services described above and related expenses, and supplementing Resolution No. 202266 in this amount.
