BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to do by City forces all the work to relocate traffic signal service and to convert series street lighting to multiple at North Harbor Drive and Nimitz Boulevard and to install new safety light to replace existing overhead at North Harbor Drive and Scott Street, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$3,200.00 is hereby authorized from Capital Outlay Fund 245 solely and exclusively for the purpose of providing funds for the work described above and related costs.
