APPROVING MAP OF LOMA PORTAL COMMUNITY UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by RICHARD T. STANDISH, Registered Civil Engineer, and entitled Being a subdivision of all "LOMA PORTAL COMMUNITY UNIT NO. 1 of Blocks 6 through 15, inclusive, and portions of Blocks 16, 25 and 26 of Western Addition, in the City of San Diego, County of San Diego, State of California according to Map thereof No. 315, filed in the office of the County Recorder of San Diego County, May 15, 1874, together with portions of Yonge Street, Zola Street, Alcott Street, Browning Street, Curtis Street, Wells Street and Worden Street, all as vacated and closed by condemnation action of the United States Government, and a portion of Worden Street dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portions of public streets, to wit: portion of Famosa Boulevard and a portion of Valeta Street for public purposes, and said portions of street are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements, listed in the Owner's Certificate on Sheet 2, for general utility and access purposes; for drainage and sewer purposes; and for open space, under the conditions expressed therein, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain easements listed in the Owner's certificate, subject to the conditions expressed therein, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
