

RESOLUTION NO. 204707 JAN 20 1972

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of HOWARD LANE, between Iris Street and State Highway 75, has been relocated by the approval on this date of the dedication of the streets within the subdivision to be known as Iris Gardens; and

WHEREAS, those properties adjoining that portion of HOWARD LANE to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as Iris Gardens; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That HOWARD LANE, between Iris Street and State Highway 75, as more particularly shown on Drawing No. 12641-B on file in the office of the City Clerk as Document No.

738710 which said drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
