APPROVING MAP OF ANDRADE PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "ANDRADE PARK Being a subdivision of a portion of 10 Acre Lots 1 and 2 and the Northerly Half of that certain strip of land 56.6 feet, more or less, in width adjoining 10 Acre Lots 1 and 2 on the South in Reiner's Subdivision of Pueblo Lot 1103, in the City of San Diego, County of San Diego, State of California, according to Map thereof in Book 1, Page 184 of Deeds, in the County Recorder's Office, the Northerly line of said strip being the Southerly line of 10 Acre Lots 1 and 2; also portions of Blocks 9, 10, 11 and 12 of Bayview Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 271, filed in the office of the County Recorder of San Diego County, July 23, 1887; also portions of Lots 8 to 14 inclusive in Block "E" of Bayview Quarter Acres, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1654, filed in the office of the County Recorder of San Diego County, December 23, 1914; also a portion of Colusa Street, Donahue Street, Eureka Street, and Fresno Street as said streets were dedicated on Map of Bayview Addition according to Map 271, filed in the office of the County Recorder of San Diego County on July 23, 1887;

also a portion of Benicia Street, Colusa Street and Andrade Street as said streets were dedicated on Map of Bayview Quarter Acres No. 1654, filed in the office of the County Recorder of San Diego County on December 23, 1914, together with a portion of Andrade Street as vacated by the City of San Diego under Resolution No. 194043, a certified copy of which was recorded in the office of the County Recorder of San Diego County on June 28, 1968 as File/Page No. 109355, and portions of Benicia Street, Donahue Street, Eureka Street and Fresno Street vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Colusa Street for public purposes and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer facilities as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress

and egress for the construction and maintenance of sewer facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
