WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where those portions to be vacated have been superseded by relocation; and

WHEREAS, those portions of BENICIA STREET, COLUSA STREET, DONAHUE STREET, EUREKA STREET and FRESNO STREET southerly of Friars Road have been relocated by the approval on this date of the dedication of COLUSA STREET by the acceptance of the final map of the subdivision to be known as ANDRADE PARK; and

WHEREAS, those properties adjoining those portions of BENICIA STREET, COLUSA STREET, DONAHUE STREET, EUREKA STREET and FRESNO STREET to be vacated will continue to have access or will be accessible by the street dedicated with the approval on this date of the subdivision to be known as ANDRADE PARK;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That BENICIA STREET, COLUSA STREET, DONAHUE STREET, EUREKA STREET and FRESNO STREET southerly of Friars Road, as more particularly shown on Drawing No. 12761-B on file in the office of the City Clerk as Document No. 738784, which said drawing is attached hereto and made a part hereof be, and the same are hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

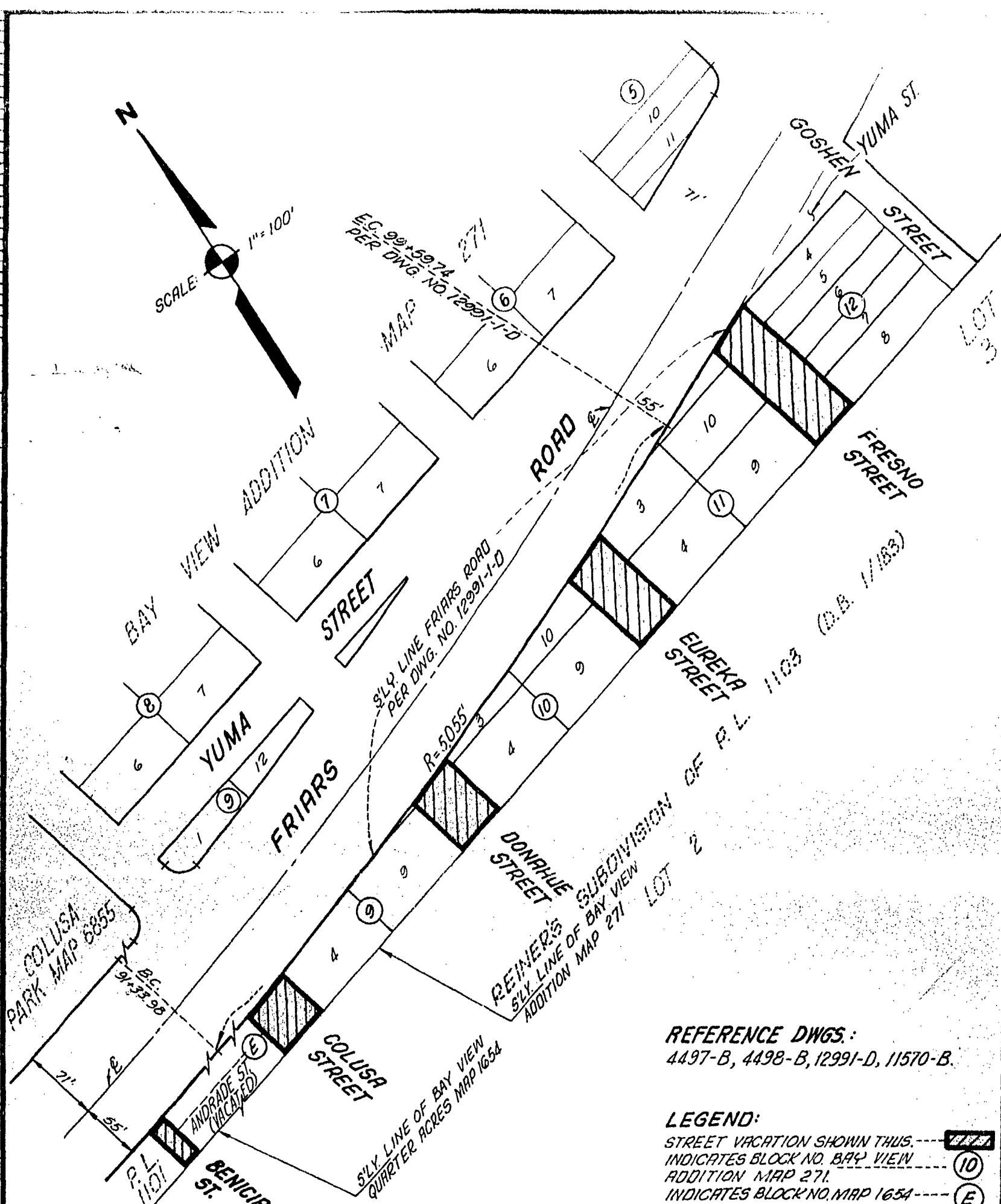
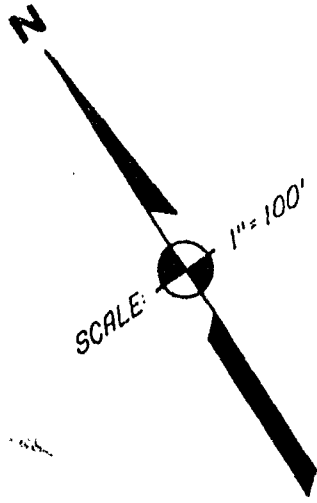
