That the City Manager is hereby authorized and empowered to do by City forces all the work for the installation of an asphalt pavement on existing dirt roads at the Chollas Nursery site, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$7,100 is hereby authorized from the Community Buildings and Improvements Bond Fund 726, solely and exclusively for the purpose of providing funds for the paving described above and related costs.
