BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager and City Attorney are hereby directed to prepare an ordinance for submission for approval to the State Department of Public Works, pursuant to California Vehicle Code, Section 35702, which would prohibit commercial vehicles with a load limit of one ton or more from using Route 163 southerly of Interstate 8 and through Balboa Park effective with the opening of Interstate 805.

BE IT FURTHER RESOLVED, that the alternate routes required to be designated under the provisions of said Section 35702 shall be Interstate 5 and Interstate 805.
