2. That the expenditure of \$106,000.00 is hereby authorized out of the Sewer Revenue Fund (506) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF PALM CITY TRUNK SEWER in the City of San Diego, and related costs.
