2. That the expenditure of \$225,000.00 is hereby authorized out of the Water Revenue Fund (502) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 187 in the City of San Diego, and related costs.
