APPROVING MAP OF OAKS NORTH UNIT NO. 2 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND V. STONE, JR. Registered Civil Engineer, and entitled, "OAKS NORTH UNIT NO. 2 Being a subdivision of a portion of Rancho San Bernardo, in the City of San Diego, County of San Diego, State of California, according to Map thereof recorded in Book 2, Page 462 of Patents, records of said County, and a portion of Pomerado Road (Mission Road 1A) as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: Plaza Abierto, Plaza Guillermo, Plaza Cerado, Plaza Animado, Plaza Del Curtidor, Paseo Del Verano, Plaza Fiel, Plaza Sonrisada, Plaza De La Rosa, Calle Cortita, Plaza Destacado, Plaza Sonada, Plaza Guata, Plaza Centrada, Plaza Amada and a portion of Pomerado Road, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Paseo Del Verano, adjacent and contiguous to Lots 11, 12, 33, 34, 35, 36, 37, 38, 46 and 46, and in and to Utopia Road, adjacent and contiguous to Lots 13 and 14, all as granted

and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities; together with the easements for open space over all of Lot 10, and over, under, upon and across all of Lots E-6 through E-8, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, and the easements for open space as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
