That this Council hereby approves in principle the concept that the Comprehensive Planning Organization should review proposed development which possesses clear, regional significance.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to request the Comprehensive Planning Organization to refine certain proposed guidelines concerning the term "regional significance" which are embodied in that document entitled "Policies and Recommendations for Determining Regional Significance and Prematurity of Development" on file in the office of the City Clerk as Document No. 738865, and to examine the problems and suggestions contained in the Report to Council on file in the office of the City Clerk as Document No. 738866.

BE IT FURTHER RESOLVED, that the City Manager and the Planning Director are hereby directed to assist the staff of the Comprehensive Planning Organization in refining the above mentioned proposed guidelines and are further directed to bring before this Council any revised proposed criteria which result from the above specified action for an appropriate Council response.
