BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Redevelopment Agency of The City of San Diego regarding Horton Plaza and providing for \$50,000 and administrative and management services for the redevelopment of the Horton Plaza area, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 738868.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$50,000 from General Fund - Unallocated Reserve 5330 to Redevelopment Agency - Plaza Redevelopment Project, to be used in carrying out the terms of the agreement with the Redevelopment Agency for \$50,000 and administrative and management services for the redevelopment of the Horton Plaza area.
