WHEREAS, the Management Team has determined and recommends one unit within the Police Department of the City of San Diego as most appropriate for recognition by the Council; and

WHEREAS, the Management Team has verified the employee organization membership of the police officers in the San Diego Police Officers Association, Inc. and recommends the granting of formal recognition to that organization; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that one representation unit within the Police Department of the City of San Diego, as recommended by the Management Team, to consist of the classifications of Police Patrolman, Policewoman, Police Motorcycle Officer, Community Relations Assistant to the Police Chief, Police Sergeant, Police Lieutenant, Police Captain, Police Inspector and Assistant Police Chief, be and the same is hereby determined to be most appropriate.

BE IT FURTHER RESOLVED, that the San Diego Police Officers Association, Inc. be and is hereby granted formal recognition as the majority representative for said most appropriate representation unit.
