1. That the bid of \$439,662.74 by C. E. Wylie Construction Co., A Corporation, for THE CONSTRUCTION OF PLAZA DE BALBOA IMPROVEMENTS IN BALBOA PARK (Base Bid and Additive Alternates #1 and #2) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738188.
2. That the expenditure of \$475,500.00 is hereby authorized out of the Park & Recreation Bond Fund (725) of the City of San Diego solely and exclusively for the purpose of providing funds for THE CONSTRUCTION OF PLAZA DE BALBOA IMPROVEMENTS IN BALBOA PARK (Base Bid and Additive Alternates #1 and #2) in the City of San Diego, and related costs.
