That Change Order No. 1, dated December 16, 1971, heretofore filed with the City Clerk of said City as Document No. 738884, issued in connection with the contract between The City of San Diego and Nielsen Construction Co. for the construction of the San Diego Hall of Science and Planetarium, said contract having been filed as Document No. 736017 in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, being an increase of \$15,553.00 and a decrease of \$11,328.69, amounting to a net increase in the contract price of \$4,224.31, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$4,224.31 is hereby authorized from Planetarium Bond Fund 920 solely and exclusively for the purpose of providing funds for the contract changes described above.
