


RESOLUTION No. 204820

Adopted by FEB 3 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That, pursuant to Section 22702 (a) of the Vehicle Code, those employees in the classification of Field Representative assigned to the Police Department and designated by the Chief of Police with authority to appraise abandoned vehicles under Section 22855 (c) of the Vehicle Code, be and the same are hereby authorized and empowered to remove vehicles from a highway or from public or private property which is located within the City of San Diego when they have reasonable grounds to believe that the vehicle has been abandoned.
