BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$7,653.75 by Sapper Constr. Co., a Corporation, for the IMPROVEMENT OF ALLEY IN PUEBLO VISTA UNIT 4, ADJACENT TO LOTS 59 THROUGH 63 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738256.
2. That the expenditure of \$11,000 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF ALLEY IN PUEBLO VISTA UNIT 4, ADJACENT TO LOTS 59 THROUGH 63 in the City of San Diego, and related costs.
3. Authorizing the transfer of \$11,000 from Trust Fund (302) to Capital Outlay Fund (245) to reimburse Capital Outlay Fund (245) for IMPROVEMENT OF ALLEY IN PUEBLO VISTA UNIT 4, ADJACENT TO LOTS 59 THROUGH 63 in the City of San Diego, and related costs.
