APPROVING MAP OF CARMEL PENASQUITOS PLAZA

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by THOMAS E. CRAIG, a Registered Civil Engineer, and entitled "CARMEL PENASQUITOS PLAZA Being a subdivision of a portion of Rancho Los Penasquitos, Carmel Mountain Road and Rancho Penasquitos Boulevard, in the City of San Diego, County of San Diego, State of California, according to Map accompanying the patent of said Rancho recorded in the office of the County Recorder of San Diego County in Book 2, Page 385 of Patents.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Azuaga Street for public purposes and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Carmel Mountain Road adjacent to and contiguous to Lots 2, 3 and 4; in and to Rancho Penasquitos Boulevard adjacent and contiguous to Lots 1, 2 and 3, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
